## Maternity Consignment Contract: Policies & Terms

There are two ways to consign maternity clothes:

- 1) Schedule a Consignor Meeting: Monday or Thursday. During this time, we will go through your maternity items while you wait. The meeting should last about 30 minutes. You take back any items that we do not accept.
- 2) Drop Off: Mon-Fri, 11am-5pm. Drop off your items in a labeled container. With this option you give us permission to keep your bin and donate any items we do not accept.

Consignment Criteria:

- All maternity clothes must be clean, wrinkle free, stain free and folded in a bin labeled with first name, last name & consignor number.
- Any maternity clothing that is stained, faded, dirty, torn, missing buttons, broken zippers, out of style, etc., will not be accepted.
- All maternity clothes must be of current style / trends.
- All new consignors must fill out a Consignor Contract before consigning with us.
- A Check-In form must be filled out by a consignor each time items are brought in to consign.
- We will accept *Spring/Summer* clothing February thru July. We will accept *Fall/Winter* clothing August thru December. No clothing will be accepted during January.

Consignment Period:

All maternity clothes will be displayed for three months from the date items are accepted. Once the items have been accepted by First Look, they shall remain on sale for the duration of the consignment period. At the end of the consignment period (90 days), the consignor will have FIVE BUSINESS DAYS to pick-up any unsold items. Each consignor will be informed of the pick-up period at the beginning of the consignment period. Any items not picked-up become the property of First Look and can be donated at the discretion of First Look. **All consignments are left at Consignor's and/or owner's risk. Consignor acknowledges that First Look shall not be responsible for damage to or loss of the consigned goods by theft, fire, negligent handling or any other cause.**

Pricing:

All maternity clothes will be priced at the sole discretion of First Look. All items may be discounted during the consignment period and are subject to any regularly scheduled sales and promotions.

Commission & Payout:

Consignors will earn 40% commission on items sold (less taxes) in the form of a cash payout. Cash payouts are made by company check and can be picked-up at the end of the consignment period.

I represent and warrant that I am at least 18 years old, the sole owner of the item(s) on consignment and the item(s) are free of lien or other claims & saleable. If any part of this contract is adjudged to be invalid, illegal or unenforceable, the remaining parts shall not be affected and shall remain in full force and effect.
